Submission Agreement

In exchange for Emerson Electric Co. and its divisions, subsidiaries and affiliated companies (“Emerson”) considering ideas and associated materials and information that I have submitted or propose to submit, I agree to and accept the terms set forth below.

- I Have the Right to Disclose my Idea:** I represent and warrant to Emerson that (i) the idea is my personal idea and no other person has contributed to it; (ii) I alone own it; (iii) I am not prohibited by contract or law from disclosing it to Emerson; (iv) if there is any possibility that my employer has any rights or interest in my idea, I have consulted my employer, and my employer does not claim any rights to or interest in the idea; and (v) if I am not a resident or citizen of the United States, I am not prohibited by export or other laws of my country of residence or citizenship from disclosing my idea to Emerson.
 - No Confidential Relationship:** Because Emerson does not wish to receive or hold any ideas or associated material "in confidence," I agree that no confidential relationship or obligation of secrecy is established between Emerson and me with respect to my idea and any material I submit to Emerson. Emerson does not have any secrecy obligation with respect to my idea or the material I submit, and I agree that Emerson may freely disclose that information to other persons

(including persons not employed by Emerson). Emerson will have the right to freely copy any materials I provide for any purpose.

3. **Submissions Covered by a Patent:** Except for the rights necessary for Emerson to evaluate my idea and the material I submit, this agreement does not grant to Emerson any rights or licenses under any patents that protect the information I submit.
4. **Possible Monetary Compensation Is in Emerson's Sole Discretion:** I agree that I shall not be entitled to any compensation from Emerson for its use of any unpatented idea or materials that I submit to Emerson. If the submission is not covered by a valid patent, Emerson has the right to freely use the information I provide for Emerson's own benefit, including, without limitation, the right to use the submitted idea and information in connection with Emerson products and services. A nominal monetary fee may be paid to me by Emerson if the submitted idea is adopted for use by Emerson and if, in Emerson's sole judgment, the idea is original and new to Emerson. Whether a fee will be paid and the amount of any such fee will be determined by Emerson, in its sole discretion. I agree to accept this fee from Emerson at any time as full compensation and as complete satisfaction for any claims that I have or wish to make against Emerson relating to its use or disclosure of any unpatented idea or material I submit to Emerson.
5. **Limitations on Emerson's Obligations:** Emerson will give each submitted idea such consideration as in Emerson's sole judgment the idea merits. Emerson will not be obligated to tell me the reasons for its decision regarding whether or not it has an interest in the submitted idea and Emerson will not be obligated to provide me with any information relating to its decision, its evaluation of the idea, or any ideas already known to Emerson that may be similar to the submitted idea. Emerson is not obligated to return any submitted materials to me.
6. **Choice of Law and Venue:** The laws of the State of Missouri will control with respect to the validity, interpretation and enforceability of this agreement, without regard to conflict of laws principles. Any legal action or proceeding related to this agreement or any submission provided by me to Emerson shall be instituted solely in the United States District Court for the Eastern District of Missouri or in a state court of competent jurisdiction located in St. Louis County, Missouri. I submit to the jurisdiction of, and agree that venue is proper in, such courts in any such legal action or proceeding.
7. **Merger of Prior Negotiations / Agreements:** Any prior representations, negotiations or agreements by any agent or representative of Emerson with respect to the ideas and information I submit to Emerson are merged into this Submission Agreement, and no such prior representations, negotiations, or agreements will be binding on Emerson or of any force or effect.

8. **This Agreement Applies to Past, Present and Future Submissions:** I agree that the terms of this Agreement apply to all ideas and materials I submit to Emerson, including past, present and future submissions.
9. **Modification / Waiver:** This agreement may not be modified or waived except in a subsequently dated writing signed by Emerson Electric Co. and specifically referencing this Submission Agreement.
10. **I am Over 21:** I certify that I am over 21 years old, or have obtained the signature of my parent or legal guardian below confirming his or her acceptance of this Agreement on my behalf.
